## **Remaining at home.**

**As family members and friends become more elderly there may come a time when they require some assistance in their home.** There are great benefits in having caring and professional personnel available at the home of your loved ones, when you cannot be there. The difference between a nursing home and receiving home health care assistance is that there is one-on-one care provided in the home. Remaining in the home often keeps your loved ones happier, more independent, and in optimal health.

## **Home Health Care with INC.**

Independent Nursing Care, LLC is licensed by the New York State Department of Health to operate as a home health care agency. Independent Nursing Care, LLC provides home care in eight western New York counties and Monroe County.

Independent Nursing Care, LLC employees are required to meet all standards as set forth by the New York State Department of Health regarding physical health and immunization standards. Independent Nursing Care, LLC has established an educational division, which offers a New York State Department of Health certified Home Health Aide training program, and in-services and educational seminars for employees, patients and family members. Criminal background checks and FBI fingerprint checks are conducted on all Home Health Care staff.

## **Home Health Care Services.**

Independent Nursing Care, LLC provides 24-hour services seven days per week to both adult and pediatric patients. Services are available on a daily, weekly, monthly or as needed basis. Care is provided in private residences, health care facilities, and in hospitals. INC can provide the following services morning, evening, or anytime throughout the day or night (*see back of card*).

*There are no contracts required for Home Care Services. You may have as many or as few hours of care as you feel necessary. Services may be discontinued at any time.*

- **RN-** Registered Nurses licensed by the State of New York.  
Provide skilled nursing services, client assessments, education, and medication management.
- **LPN-** Licensed Practical Nurses licensed by the State of New York.  
Provide medication management, wound care, personal care, and other nursing duties.
- **HHA-** Certified Home Health Aides.  
Assist clients in the home with personal care, light housekeeping, laundry, meal preparation, and other activities of daily living activities.
- **Hairstylist-** Licensed by the State of New York.  
Comes into the home or facility for a cut, style, and/or perm for women, or a shave and/or cut for men.

## **Home Health Care for someone you love.**

**Staff members of Independent Nursing Care, LLC are guests in the home of our clients.** We help to provide assistance in maintaining the home based on client wishes. Staff provides professional, individualized, one-on-one care with a goal of establishing lasting relationships between the patient and caregiver.

## **Scheduling.**

Independent Nursing Care Home Health Care Services are initiated with an in-home visit from our Assistant Director of Nursing. This nurse meets and speaks directly with the client and all other family members or friends involved in the home care process. The INC nurse will set up a Plan of Care that is individualized to the needs and wishes of our new client. The Plan of Care remains in the home with a chart that is carefully monitored, followed, and kept up to date by staff each time they are in the home.
